

Rotary Club of La Crosse After-Hours Membership Dues Contract

Annual club dues are \$160 if paying quarterly (\$40/quarter), or \$150 if paying annually. The dues cover membership to Rotary International, a subscription to The Rotarian magazine, club liability insurance, and council on legislation. A fee of \$10 will be charged for each meeting attended and are not included in the annual club dues. Meeting fees include food and facility. They can be paid in the form of cash, check, or card at each meeting, or prepaid alongside your dues. Card transactions (processed through PayPal) are charged an additional processing fee. Please make a choice for your preferred dues and meeting fee payment option below. Members whose forms are not returned within 30 days of being approved will automatically be billed Yearly (no meeting fees included).

| And Yearly Dues/Meeting Fees \$390 (includes dues and pre-paid meeting fees for the entire year). This option is convenient for those that will be regularly attending all meetings, and favorable to most employers who are paying employee memberships on annual budgets. <i>Please have your name indicated on the company check!</i> |
| Yearly Dues Only \$150 (\$10 cheaper than paying dues quarterly, but does not cover any meeting fees). The meeting fee of \$10 will be collected for each meeting attended in person at the registration table. |
| Quarterly Dues/Meeting Fees \$100 (includes dues and pre-paid meeting fees for 6 meetings, which is 2 per month). Instead of paying the full dues/meeting fees for the entire year, you be invoiced at the beginning of each quarter. |
| Quarterly Dues Only \$40 This option is the most affordable way to maintain membership in the club. The meeting fee of \$10 will be collected for each meeting attended in person at the registration table. This option also might be preferable to those who feel they may have scheduling or time constraints that don't permit them to attend most meetings in person. |
| Dues will be prorated for the quarter or year based on your join date. |

A bill, based on your above selection, will be sent through ClubRunner in July for those that choose Yearly; and in July, October, Jan, and April for those selecting Quarterly. <u>Please wait to receive an emailed invoice before paying</u>. The Board reserves the right to increase meeting fees for the current fiscal year if inflation results in collected meeting fees not entirely covering the club's costs. Payments are due within 30 days, at which point a reminder will be sent. After 60 days past due and an additional email reminder, membership may be terminated upon Board approval. Dues are required to be paid even if you are unable to attend meetings and events.

If you wish to take a leave of absence or resign, you must submit in writing to the club president within 30 days. Your balance will need to be paid in full to remain in good standing and have the option to rejoin Rotary in the future.
